

Terms & Conditions Christ Church Plano Tour of the Greek Islands May 25 – June 6, 2024 \$5,895 Per Person, Land Portion

This tour is based on rates in effect November 10, 2023 and is subject to change in the event of significant currency fluctuations. This tour is priced on a minimum of 30 paying participants.

ACTIVITY LEVEL: The activity level on this tour is moderate. Participants should be in good health and able to walk at a moderate pace on uneven terrain for up to three miles in hot weather over the course of a day. Certain sites require climbing multiple flights of stairs that may not have handrails.

INCLUDED IN PRICE: Shared double room in five star and boutique hotels; single rooms will not be offered on this trip. Daily meals as indicated in itinerary; transportation and entrance fees to sights and museums, as listed in itinerary; ferries and airfare as listed in itinerary; taxes, fees, and gratuities.

NOT INCLUDED IN PRICE: International airfare; potential increases in the airline tax/fuel surcharge; individual transfers; drinks at lunch and dinner; excess baggage.

RESERVATION AND DEPOSIT: A non-refundable deposit of \$500 per person is required at the time of reservation. The balance is due no later than December 6, 2023. For reservations received after this date, payment must also include a \$275 late booking fee per person in addition to any subsequent increases in the price of airfare.

TRANSFER: Group transport between airport and hotel is included. Those who request changes from standard program and who do not arrive with the group are responsible for their own transfers. Those who request changes from the standard program and who do not arrive Athens on May 25, 2024, please be in touch with us for special arrangements.

LUGGAGE: Limit of one suitcase and one carry on per person; porterage is for one suitcase only. Transporting carry-on luggage is the responsibility of passengers.



FLIGHT TIMES: International group flights from DFW will be available in late November, 2023. Flight times are subject to change without advance notice. If there are flight changes that necessitate extra overnights, you will be charged \$300 per night per person.

CANCELLATION FEES: Footstep Ministries must receive all cancellation and refund requests in writing. All cancellations are subject to an administration fee of \$500 per person if received on or before December 6, 2023; 25% of tour price if received between December 7, 2023 and March 26, 2024; 75% of tour price if received between March 27 and April 25, 2024; and 100% of tour price on or after April 26, 2024. No-shows or cancellations after date of departure receive no refund whatsoever. All cancellation fees are based on the total tour price including all additions and upgrades.

INSURANCE: Tour participants are highly recommended to purchase insurance for trip cancellation, trip interruption, accident, sickness and/or loss of baggage and personal effects. Insurance can be quoted and purchased from the tour registration page, or by <u>clicking here</u>.

DOCUMENTATION: U.S. citizens require a valid passport. Passport expiration date cannot be within 6 months of the completion of the tour. The traveler assumes complete and full responsibility for, and hereby releases FM from, any duty of checking and verifying any and all passports, visa, vaccination or other entry requirements for each destination, and all safety and security conditions during the proposed travel.

The right is reserved to substitute hotels and cruise ships and to alter itineraries. FM reserves the right to cancel the tour prior to departure. If any tour is cancelled prior to the passengers joining the tour, FM is liable for a refund of monies received. FM is not responsible or liable for defaults of those not directly under the control of FM.
